### **About Visa Verification Service enquiries**

A Visa Verification Service Enquiry Record shows details of the visa record held by Immigration New Zealand (INZ) for a particular visa holder. All non-New Zealand citizens must hold a visa to be in New Zealand. All visas are held in INZ's electronic records. Some visa holders receive a visa label in their passport, and some visa holders have eVisas (label-less visas). The Visa Verification Service allows service providers in New Zealand to verify a person's visa status where the person does not have a visa label in their passport.

#### **Identity assurance**

A Visa Verification Service Enquiry Record confirms that the details of the visa you have been presented with match the details of a visa in INZ's electronic records. You should also sight a passport or other appropriate identity document to ensure that the biographic details in the identity document match the biographic details in the visa, and that the photograph in the identity document matches the person presenting this information.

#### Validity

Visa Verification Service Enquiry Records are current on the date conducted, and the information provided is valid at the date stated on the Enquiry Record. Visa information may change. Where a person is not yet in New Zealand, their visa may be subject to the grant of entry permission at the New Zealand border.

## Privacy

A Visa Verification Service enquiry must only be performed with the consent of the visa holder. Please treat this document and the personal information it contains in accordance with the Privacy Act 2020. You must only use the information for a lawful purpose; only retain the information as long as required for that lawful purpose; only share the information if authorised by the visa holder or otherwise permitted by law; and if storing, sharing or destroying any electronic or hard copy version of this information, do so in a secure manner.
