## Important Note

This Visa is issued to you based on the information provided in the application for which you have truthfully declared to be so or for which you had consented for a proxy to submit on your behalf and are fully aware of the information so provided by you authorized proxy.

A New Zealand visa is not an immigration pass. It is a pre-entry try permission for you to travel to and seek entry, into New Zealand. A holder of a valid New Zealand visa who is found suitable for entry into New Zealand will be used with an immigration pass to enter and remain in New Zealand.

Possession of a valid visa alone does not guarantee entry into New Zealand. You must also meet the following entry requirements

- Hold a passport with at least 6 months validity.
- Have sufficient support for the period of stay in New Zealand
- Have Confirmed Onward/Return air ticket(s).

The grant of an immigration pass to you will be determined by the immigration & Checkpoints Authority (ICA) officers at the point of entry. The period of stay granted is shown on the visa pass endorsement given on your passport and it is not tied to validity of this visa. Please check your passport for the arrival endorsement and take note of the period of stay granted before leaving the checkpoint.
